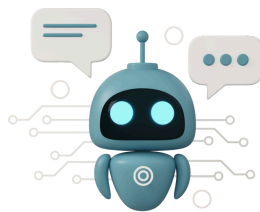
1. **Login to the App:** Use registered credentials to access the retailer account.

This QR code helps in building trust and streamlining transactions.



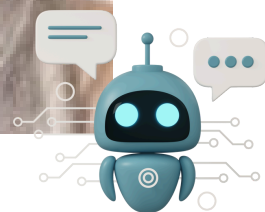

INCOME CALCULATION

There are four types of income. The first two—appointing distributors and earning from orders placed by retailers under your distributors—are essential for building a good income.

The other two—appointing direct retailers yourself and earning from their orders—are optional and can be started after your first 90 days. This approach helps you focus on stable growth in the initial phase, while opening up additional earning opportunities later.

Income 1 - Appoint Distributors & Earn

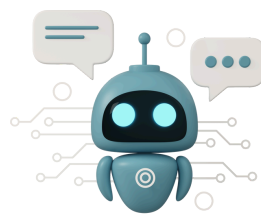
Income 2 - Earn from Orders (via Retailers made by your Distributors)

Both of the above are mandatory to earn a good income.

Income 3 - Appoint Direct Retailers (You act as a distributor here)

Income 4 - Earn from Orders (via Retailers made by You as Distributor)

Income 3 and 4 are optional, and you should start these after completing 90 days of your work.

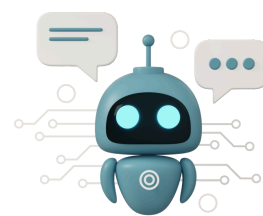

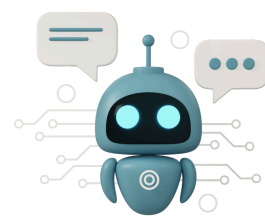
Assume you receive 600 high-quality leads (Via us) from Tier-3 cities, just like the ones we provided you. We ask all budget-related questions first, so you get only serious prospects.

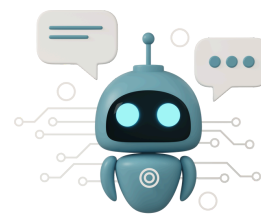

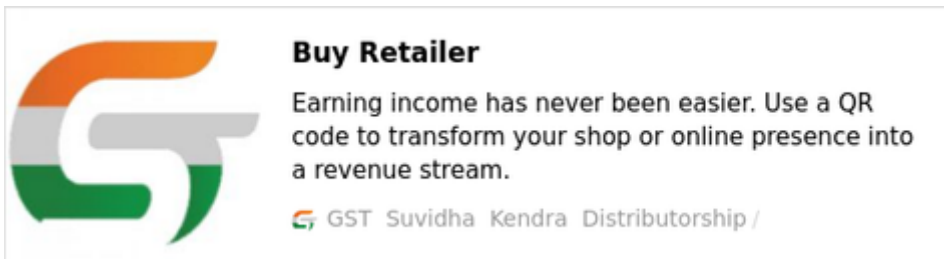

You can appoint unlimited retailers across your entire district.

INCOME 4 - OPTIONAL (DEPENDS ON INCOME 3)

Earnings Projection from Active Retailers

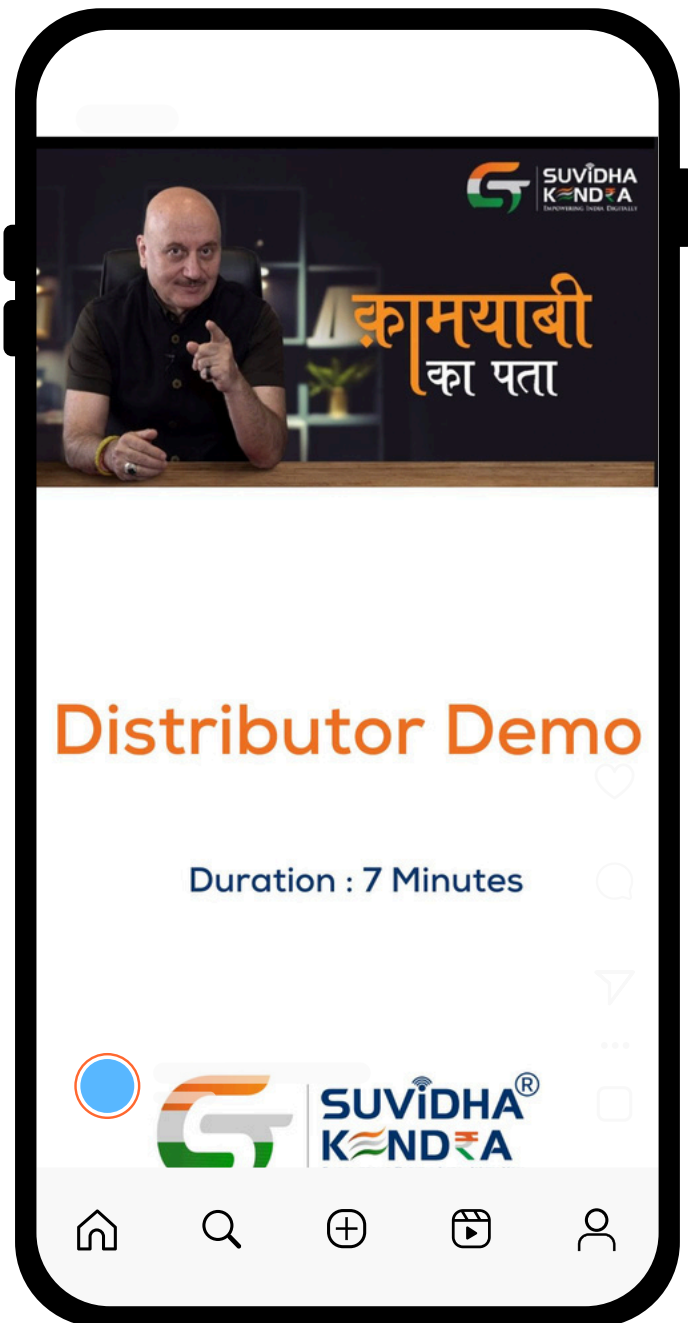

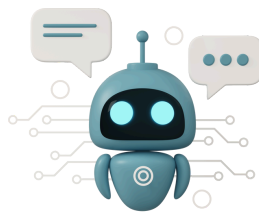

■ ABOUT THE ROLE

What is the role of a Master Distributor?

You get exclusive rights to appoint city/pincode-level distributors in your district and earn commissions from each appointment and their activities.

Can I appoint retailers directly too?

Yes, you can appoint retailers under your own ID using your dashboard – and earn 100% profit + commissions on their transactions. You need to make yourself as a distributor for doing this.

Do I need an office to start?

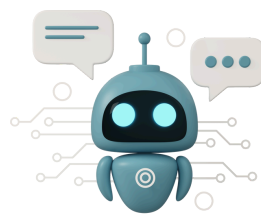
No office is required. This is a fully digital, remote-operable model.

Is this appointment valid for lifetime?

Yes, the Master Distributor appointment is lifetime – with no renewal fee. You need to achieve 5 Lakh Rupees Yearly target. You can do it via Distributor Appointment, Retailers Orders or mix of both.

Do I get territorial exclusivity?

Yes, you are the only Master Distributor for your assigned district.

How do I earn as a Master Distributor?

You earn 50% commission from every distributor appointment + ongoing income from the orders generated by their retailers.

How much commission do I get per distributor sale?

When is my commission released?

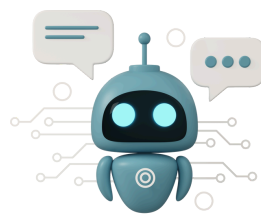
After the distributor's payment is confirmed and onboarding is completed by the Head Office. Payment cycle is net-15 days basis.

How do I earn from retailer transactions?

You earn indirect commission when retailers (under your distributor network) provide services like GST filing, ITR, food license, etc.

Is there any monthly target or pressure?

There is no pressure. You need to achieve 5 Lakh Rs Annual target via orders or via appointment of distributors or both.

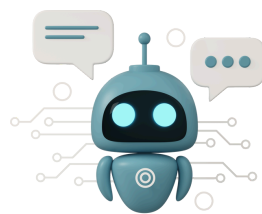

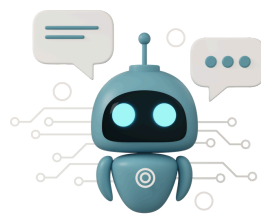

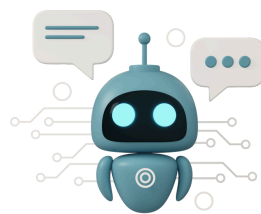
